Our criteria remain the same: all products sold at the LFP Farmers Market/ Indoor Holiday Crafts Fairs are handmade by you in the State of Washington. We also require that you personally represent your work at the event.

Please submit by postal mail. For guaranteed consideration, application packets must be complete and **received by October 8th**:

- Completed and signed application.
- 3 photographs to represent current work, clearly labeled, and attached to description form. Color images downloaded and printed on regular paper are acceptable.
- Photocopy of your Washington State Business License.
- Check for \$50 for one market or \$100 for both, made out to Friends of Third Place Commons. Your check will be returned if you are not selected to take part in the event(s).
- Self-addressed Stamped Envelope for return of check (if not selected) and of photos (if requested). Please ensure you've included sufficient postage and a suitable envelope if you require return of your photos.

We will be making selections from the entire pool of applicants in mid-October, and you will be notified of your status by email no later than October 16th. If you have any questions, please send a message to programs@thirdplacecommons.org, or call 206-366-3302.

I understand that this is a juried event, and that my application packet must be **received by October 8th** for guaranteed consideration. I also understand that event set-up is at the discretion of the Market Manager and event organizers and that my space will be determined by them.

I agree to hold harmless the LFP Farmers Market, Friends of Third Place Commons, Merlone Geier Partners, or the City of Lake Forest Park from any and all claims and actions arising out of my participation in the Farmers Market, including loss, damage or injury to person or property.
